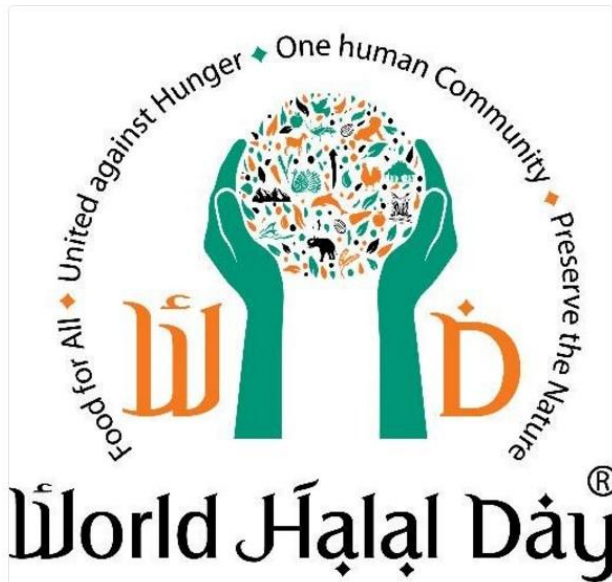

Opatija's Declaration

As a part of the yearlong celebration of the 100th anniversary of the official recognition of Islam as an equal religion in the Republic of Croatia, Center for Halal Quality Certification, in cooperation with the United World Halal Development organization in Singapore and sponsored by the Ministry of Tourism, the Ministry of Foreign and European Affairs, Ministry of Economy and the Ministry of Agriculture and with the support of Opatija, Primorje-Gorski Kotar county, Croatian Chamber of Commerce, the Croatian Tourist Board and the Tourist Board of Opatija, as well as Republic of Turkey as the partner country, with the support of the Islamic Republic of Iran organized World Halal Day Croatia, the first international halal event in Croatia from 2nd – 4th November 2016, with theme: "Latest Trends and Opportunities in the Fastest Growing Market of the World". After three days of panel discussions and presentations, gathered political representatives, religious dignitaries, manufacturers, service providers, researchers, representatives of halal certification and standardization institutions and financial institutions, representatives of the economic and tourist chamber of Croatia, Belgium, Great Britain, France, Spain, Italy, Bosnia and Herzegovina, Serbia, Montenegro, Turkey, Malaysia, Indonesia, Iran, Algeria, the United Arab Emirates, Qatar, Kuwait, Saudi Arabia, Australia, Singapore, Spain, Sudan, Canada, Azerbaijan, Russia, Norway, United States of America and Slovenia are aware that:

- ❖ concept of halal represents a style of life and it is not merely related to halal meat and the method of slaughtering
- ❖ halal does not exempt anyone, furthermore, halal adds an additional quality for each product and service
- ❖ the value of the halal market is currently estimated at 2 trillion US dollars
- ❖ the world's biggest economies want to participate more actively in the halal market
- ❖ halal has been misused for commercial purposes such as self declaration of halal without any certification procedures
- ❖ issuing halal certificates from unauthorized institutions and individuals
- ❖ endless discussions on halal slaughtering modes and stunning methods
- ❖ the various initiatives in the establishment of a uniformed halal standards in production and service provision
- ❖ opportunities and potential offered by Islamic Banking and Finance
- ❖ initiatives and strategies of different countries to become leaders in the Islamic economy
- ❖ the various initiatives in the establishment of a uniformed halal standards in production and service provision
- ❖ opportunities and potentials offered by Islamic Banking and Finance
- ❖ initiatives and strategies of different countries to become leaders in the Islamic economy

Opatija's Declaration

Expressing gratitude to the Republic of Croatia, which has recognized Islam as an equal religion 100 years ago and thus established a legal framework for the institutional development of halal, which has resulted in the registration of halal standards in the Croatian Standards Institute, we hereby issue:

OPATIJA's DECLARATION which:

- I. Condemns any attempt to misuse the halal for any purpose.**
- II. Calls on the acceptance of the interpretations of halal exclusively by authorized institutions.**
- III. Welcomes the establishment of a unified halal standard in the Republic of Croatia and the region.**
- IV. Calls upon all countries of the European Union and beyond to the establishment and implementation of halal standard and accreditation of halal certification bodies taking countries in Southeast Europe as an example of good practice.**
- V. Taking into account the halal certification activities performed by Muslim communities/institutions in Non-Muslim countries over the last 30 years; invites the standardization bodies in Muslim countries that study in the fields of halal tourism, production, certification and accreditation, to cooperate with the Muslim communities/institutions in non-Muslim countries and welcomes all activities to reach common halal standards.**
- VI. Welcomes the establishment of accreditation of halal certification bodies, and invites all countries to accept a unified accreditation in the world as the only true way to full regulation of the halal market.**
- VII. Supports the current initiatives and strategies of some countries to become leaders in the Islamic economy, based on the principle of transparency and mutual respect.**
- VIII. Welcomes the implementation of halal standards in schools of the Republic of Croatia considering it as a positive example which should be followed by all public institutions in the World**
- IX. Invites educational institutions to establish special courses in order to better understand the possibilities and future development of the halal market.**
- X. Invites the scientific institutions to established monitoring of halal and scientific development of the same.**
- XI. Urges financial institutions in the application of Islamic banking and finance models as a models that can provide fresh capital and investment in particular sectors leading to positive examples in the world.**
- XII. Ask all political representatives, religious dignitaries, manufacturers, service providers, scientific and academic communities, halal certification bodies, accreditation of institutions, standardization and financial institutions, commercial and tourism chambers to adopt and implement this declaration.**
